This means that there can be an increasing awareness of the need to address the drivers of this loss but also that IPBES ³⁰ should be a tool with a focus that is useful in this regard. This should be at the heart of your discussions in the coming days on the thematic content of the future IPBES work programme.

Policy makers need guidance

Biodiversity is not a new issue. But despite global actions, biodiversity is still declining and ecosystems are still threatened. In the EU our previous biodiversity strategy did not manage to halt the loss of biodiversity by 2010.

We therefore need a platform that can guide us policy makers to decision making and prioritized action.

⁵⁵ No doubt the challenges are many and I strongly believe that IPBES can play a critical role when it comes to identifying key scientific information needed for policy makers. Prompt response to government needs is also of great importance.

IPBES will become a crucial tool

In this context one item is crucial. It is the valuation of ecosystem services. An

70 increasing population and pressure on resources makes the valuation of ecosystem services the only possible way forward.

Therefore we need to draw attention to the global economic benefits of biodiversity and to highlight the growing costs of biodiversity loss and ecosystem degradation.

I know that this alone is not an easy task. How do you value the plant which keeps supplying the atmosphere with oxygen? Even though this is very difficult,

It is a very important task and we need to gather expertise from the fields of science, economics and policy to enable practical actions moving forward.

There is no doubt in my mind that not only do we need solid scientific information about the trends in biodiversity, we also need a platform which gather all available information on biodiversity, ecosystem services and their relation to human well-being.
